I also understand that I must first receive training in sexual abuse prevention (as provided by the school) before working with students. The school may refuse employment or volunteered serviced or terminate conditional employment if the school deems any background information unfavorable or that it could reflect adversely on the school or on me as a Christian role mode.

I understand that this is only an <u>application</u> for employment or a volunteer position and that no employment contract or assignment of a position is being offered at this time.
